1. The stallion breeding fee for frozen semen is in PROMO €1050 (available until January 31st, 2026). All fees must be paid, contract signed by both parties, and a copy of mare's papers to Stallion Owner before receiving semen.

Payment in Euros by bank wire. The offer becomes valid with payment of €250 (plus VAT if applicable) booking fee within 14 days after signing of the contract to the account SI56 2900 0005 2683 952. The remaining €800 (plus VAT if applicable) need to be paid prior to semen shipment. Booking fee is not refundable.

2. Stud Fee does entitle mare owner to Live Foal Guarantee. I am entitled to ONE "live foal" conceived (per frozen semen contract) from this breeding that will stand and nurse after foaling without assistance and lives for (24) hours. If my mare is found not in foal, or delivers a stillborn, I am allowed a Rebreed Contract if Stallion Owner is notified within (15) days of the discovering the mare is open or foal is stillborn. With the notification there must be a statement from a licensed veterinarian. A Rebreed contract will apply to the following breeding season only, and the Stud Fee will be nonrefundable. Live Foal Guarantee will be null and void if Mare Owner does not give ample opportunity to settle mare. Stallion Owner will also be released from Live Foal Guarantee if mare is sold without notifying the Stallion Owner and providing new contact information. With Re-breed agreement the Mare Owner is required to pay all other veterinary related fees and board.

3. If mare owner needs to change which mare they are going to breed a new contract must be signed with replacement mare's name and registration #. Mare owner may not assign this breeding contract or substitute any other mare under this agreement without the prior written consent of the stallion owner. Any attempted assignment without prior consent of stallion owner will, at the option of stallion owner, terminate this agreement and release stallion owner from all obligations hereunder.

4. The stallion manager agrees to furnish 1 breeding dose (8 straws per dose) for the above listed stallion per frozen semen contract. Since the stallion has exceptional semen quality we give possibility to order just one dose (8 straws) of frozen semen. Initial order can be extended with additional dose of 8 straws for the fee of €100.00.

If further shipments are necessary past the initial agreed upon stallion owner furnished doses, the mare owner will be required to pay Stallion Owner €250.00 per additional dose (8 straws per dose).

The mare owner is responsible for any and all costs/fees associated with shipping the frozen semen.

5. Mare owner agrees that only the mare designated on this contract will be inseminated with the shipped semen. Any attempt to breed more than one mare with a shipment will void this contract.

6. BREEDING OF THE MARE BY FROZEN TRANSPORTED SEMEN. The Mare owner is responsible for all facets of breeding the Mare and agrees to comply with all related breed association requirements concerning the use and handling of frozen semen. The Mare Owner agrees that an individual who is qualified and experienced in the use and handling of frozen semen will perform the insemination. The Mare Owner agrees to use the semen provided by this Agreement for the Mare named in this Agreement and no other.

THE STALLION MANAGER MAKES NO WARRANTY OR GUARANTY, EXPRESS OR IMPLIED, WITH RESPECT TO FROZEN SEMEN, INCLUDING, WITHOUT LIMITATION, THE WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. THE STALLION MANAGER MAKES NO GUARANTEE OF DELIVERY WITHIN A CERTAIN TIME PERIOD AND MAKES NO GUARANTEE THAT THE FROZEN SEMEN WILL SAFELY REACH THE INSEMINATION POINT WITHOUT LOSING INTEGRITY, QUALITY, OR CHARACTERISTICS.

7. EMBRYO TRANSFER. I understand that if an embryo transfer is preformed and multiple embryos are recovered during the embryo harvesting I will be accountable for an additional stud fee of €1200 (+VAT), within (60) days of confirming pregnancy in order to receive a certificate for the additional foal(s). If a conception from a multiple embryo harvest does not produce a Live Foal after the Mare Owner pays for the additional Stud Fee(s), it is the Stallion Owners discretion to refund the Stud Fee for the additional conceptus or allow it to be counted as a Rebreed for the following breeding season.

8. It is further agreed that if the mare dies before producing a live foal or becomes unfit to breed before being pronounced safe in foal, a substitute mare will be allowed for the current breeding season or the following season only. No Stud Fee will be refunded. If multiple embryos are recovered and produce multiple pregnancies from embryo transfer, any subsequent foals born from breeding besides the ONE live foal guaranteed from this frozen semen contract, the mare owner will be responsible for paying the €1200 (+VAT) stud fee for all extra foals born. No breeders Certificates will be granted until stud fee is paid to Stallion Owner.

9. A "Breeder's Certificate" will be issued for the foal conceived by the mating when stallion fees and all other expenses have been paid in full. The Mare Owner will receive a Breeder's Certificate when the Stallion Manager has been notified that a live foal has been produced.

10. This contract shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended, except by written mutual consent of the parties hereto.
